B. Staff Reports, Deputations, and Presentations

B.1 Deputations, if any

B.1.1 Stephanie Fletcher, University of Guelph Re: Student Case Study – Naturalizing and Restoring Landscapes - Gateway Site

Councillor Sampson welcomed Stephanie Fletcher, University of Guelph, who provided a presentation regarding her Student Case Study – Naturalizing and Restoring Landscapes – Gateway Site. Stephanie noted she has lived in Thornbury since 2020 and is currently enrolled in University of Guelph's Diploma in Horticulture program. Stephanie is also a Master Gardener in Training.

Stephanie provided an introduction and context, reviewed inputs used to develop her Case Study for the Gateway Site, and provided an overview of green space infrastructure and low impact development to balance urban development. Stephanie reviewed the green space benefits, which include social, environmental, and economic benefits. Stephanie advised that the "green space" definition is broad enough to encompass parkettes, and the value attributed to these spaces can actually be quantified. Stephanie reviewed the Gateway Site challenges and considerations, along with the naturalization opportunities which include: tree canopy, permeable paving, rain gardens or conservation landscaping, bio-retention swale, green roof systems on public transport/bike storage/other storage facilities, rainwater harvesting, partially covered parking spaces for registered car pooling groups, canopy shading, native plants as largest percentage of vegetative cover, and new tree canopy. Stephanie advised that her reason for performing a Case Study on The Gateway Site is the physical site represents the Gateway to Thornbury, and as such, there is an opportunity to include verdant green space and forward-thinking design that balances new green development with economic objectives.

Stephanie provided additional detail on rainwater harvesting, preservation or increase in tree and vegetation cover, stormwater management practices including: permeable paving and green roofs for bus shelters, bike storage and other outdoor buildings, and rainwater gardens or conservation meadows.

Lastly Stephanie reviewed the current plan view of the Gateway Site with commentary regarding the green design options previously identified.

Board member Cary Eagleson enquired as to how permeable paving technology stands up against snow removal equipment. Stephanie advised that there are case studies suggesting that it stands up as well as regular pavement.

The Board requested that Stephanie review the Gateway Site Design Guidelines as provided at Item B.1.2 and to provide insight into how some of the wording within may be supplemented to account for her Case Study findings.

B.1.2 Eldon Theodore, MHBC Planning, Urban Design and Landscape Architecture Re: Gateway Site Design Guidelines

Councillor Sampson welcomed Eldon Theodore, MHBC Planning, Urban Design and Landscape Architecture who provided a presentation of the Gateway Site Design Guidelines. Eldon noted the guidelines were initially prepared in January 2021, but have since been amended based on feedback received. Eldon noted the Design Guidelines are meant to provide visioning and direction to the successful proponent for the Gateway Site.

Eldon further noted the Design Guidelines lay out general design principles for the Gateway Site including private space design, non-residential space design, interior space, accessible design, public space design, and sustainable design. Eldon noted the comments provided during Item B.1.1 are very helpful as well and provide further insight into sustainable and green design features.

Board member Janet Findlay thanked Eldon for the report, and cited its easy readability and layout. Janet noted there is minor inconsistency in storey levels on pages 3 and 12 respectively. Janet further commented that the Design Guidelines Task Force had requested a further setback from the road, while the current Design Guidelines appear to have the setback closer to the road. Eldon noted that the current setback as identified in the document attempts to satisfy both the feedback from the Task Force, and the Town's Official Plan which encourages the built form close to the street. Eldon further noted that when the building is set further back from the road, it could impact the number of parking spots available at the rear of the building.

The Board discussed that comments are expected from Stephanie Fletcher, University of Guelph, as well as the Board which means a final version of the Guidelines will need to presented at a future meeting. Ed Starr of SHS Consulting advised that there is still time to refine the Gateway Site Design Guidelines as the Concept Architect still has not been retained. Councillor Sampson noted he has also been asked to present the Design Guidelines to the Sustainability Advisory Committee, which will give a little extra time to finalize the document.

Councillor Sampson enquired whether Eldon had any feelings about the proposed setback and naturalized design elements proposed by Stephanie Fletcher during B.1.1. Eldon noted that he generally supports the move to include naturalized design elements, but the property should be prominent; there is a balance to be struck between a "sense of arrival" to the community and sustainability initiatives on the site.

Board member Cary Eagleson commented that he likes the concept of natural green areas with flowers and native plantings, but noted a priority will be ensuring maximum tree retention on the lot. Soft landscaping at the front of the building would be an appropriate look and feel.

Mayor Soever requested clarity regarding page 4, and noted it is blank with the words "placeholder for massing model". Eldon clarified that the Design Guidelines are intended to be a living document, and the successful proponent's design concept should be added to page 4.

Mayor Soever requested further clarity regarding accessible design concepts and whether the unit sizes will be sufficient to accommodate those standards. Eldon advised accessible design can be further contemplated by the architect but the Design Guidelines include the minimum standards. Mylene Vincent, SHS Consulting advised that the accessible design concepts are feasible within the smallest unit size. Mylene further noted the Board may wish to revisit the 1,100 square foot, three bedroom unit size, and noted that they could be designed comfortably at around 950-1,000 square feet.

Board member Janet Findlay noted the document is flexible in its current state, with many *mays* rather than *shalls* when it comes to design considerations. Eldon noted that the wording around the design standards have been strengthened from the original document. Mylene noted that several of the design principles in the document should remain as *shalls* – for example, the stepback from the third storey.
